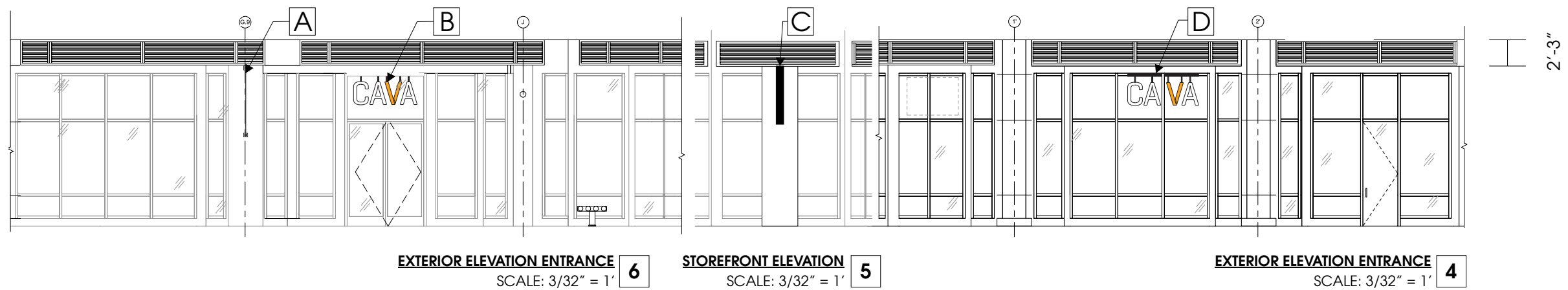


CONSTRUCTION FLOOR PLAN

SIDE VIEW



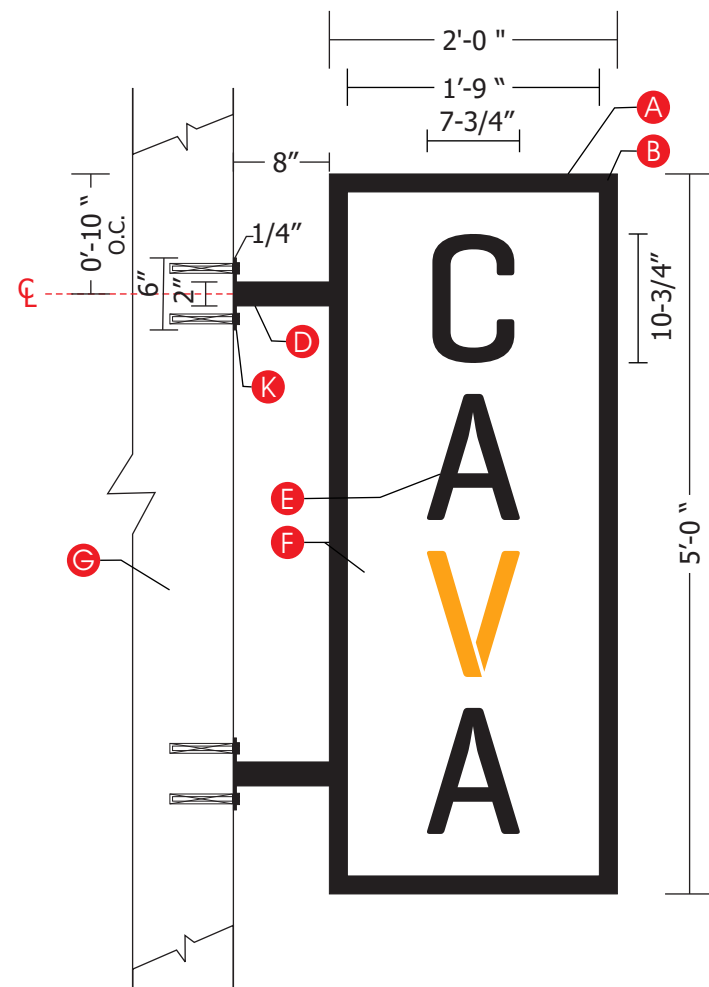
WALL SECTION - COLUMN

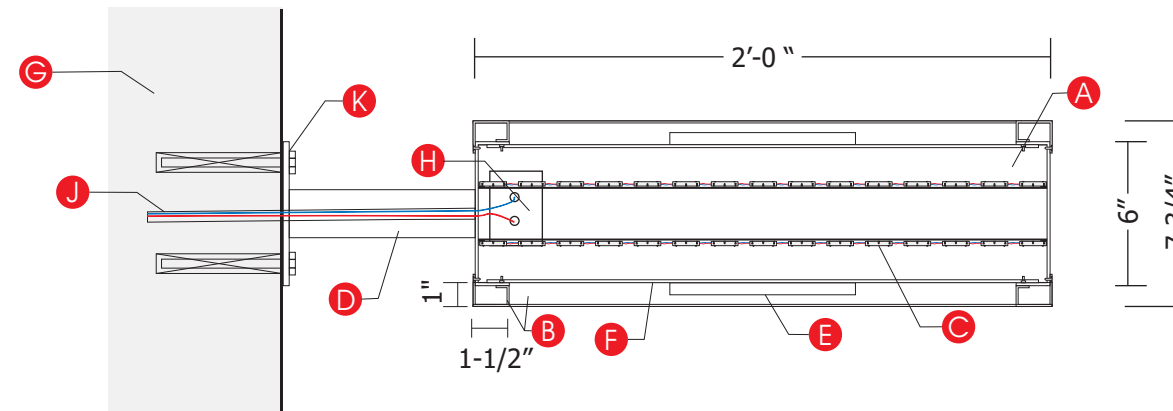

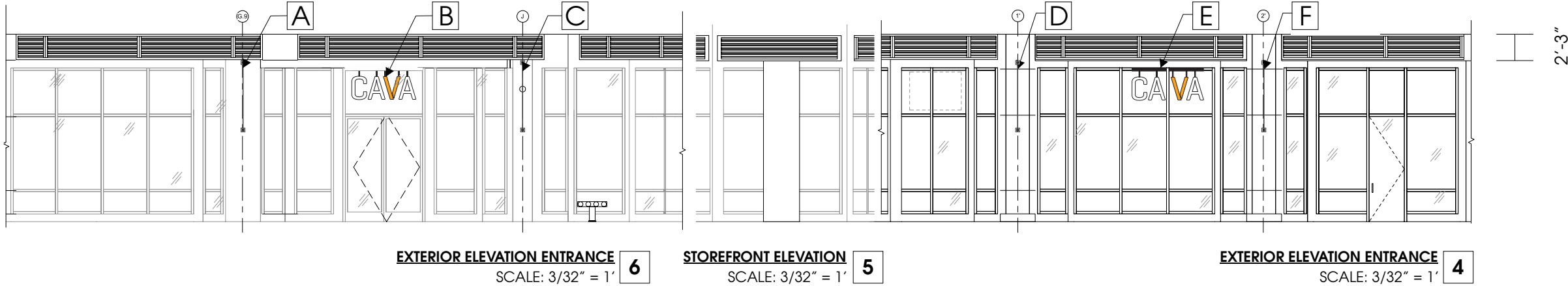
PIONEER WAY VIEW - NIGHT
