<p>Notice is hereby given that the following docket entry has been made in the above captioned matter:</p> <p>The Ronos and CRA's Agreement for Judgment confirms in the Ronos their title to the "5-Foot Strip." Neither the Agreement nor the parties' pleadings, however, depicts the location or dimensions of the Strip. The Court thus <b>ORDERS</b> the Ronos and CRA to file by July 28, 2023, an agreed plan or other depiction of the Strip that shows its location and dimensions. The Court intends to attach such a depiction to the Default and Agreed Judgment that will issue in this case.
