Project Updates

Rindge Connectivity Community Engagement
Outreach at 362, 364, and 402 Rindge Avenue, as
part of the CRA's Rindge Avenue Community
Connectivity project, is underway. In May, the CRA
hired three Engagement Coordinators, Hiwot
Bekele, Asmait Tekle, and Linda Vick to guide and
facilitate engagement that seeks to understand
residents' perspectives on open space and
connectivity where they live. As part of the first
phase of outreach, the coordinators are distributing
a survey to residents to understand their goals and
preferences for the project, which has been
translated into nine languages: Amharic, Arabic,
Bangla, Simplified Chinese, English, Haitian Creole,



Hindi, Spanish, and Urdu. Thus far, the Engagement Coordinators have received 247 survey responses. The survey will remain open through the end of this week.





Center Plaza Design Community Engagement CRA staff continue to conduct community

outreach to seek feedback on the updated Center Plaza design. The staff has tabled at the Proto residential building to get residents' thoughts on the design, as well as at the Pisani Center. To receive additional input from residents at the Washington Elms and Newtowne Court, CRA staff will table at the weekly game night every Monday until August 7. Galaxy Park Concept Design

The CRA presented concept design options for proposed improvements to Galaxy Park at the City of Cambridge's Joint Transportation Committee meeting, held on June 29. Members of various City community committees, including the bicycle committee and pedestrian committee, were present and offered feedback on the design options under consideration for both Galaxy Park and for the surrounding streetscape. Pending further conversation with City staff, CRA staff expect to bring a park concept and streetscape concept to the Board's next meeting for approval to move into 25% design plans.

Forward Fund

The CRA opened the Forward Fund Capital Infrastructure Grant Program on June 21. Over the past few weeks, CRA staff have spent time informing organizations about the new grant allocation, and conducting site visits and virtual meetings to discuss grant opportunities.
