Parcel 6 Deaccession Report – Totem Artwork

Basic Information

Title of work: *My Totem* Location: *Parcel 6, corner of Third and Binney* Year Created: *2017*

Materials Used: Plywood

History

The My Totem Project supported Community Art Center students ages 9 to 12 in the exploration of identity, family and community through the creation of their own personal "totem poles." Each totem pole was hand painted on 2' x 8' plywood pieces. The final installation consists of 18 panels hung vertically with 1' between each one and occupies approximately 60 feet of the chain link fence on Parcel 6. In the Pacific Northwest, the totem pole is often used as a symbol of welcome. The panels welcome visitors to the lot, and have collective visual impact through the use of a common color scheme and design features. Traditional totem poles include symbols that express cultural beliefs or recount familiar legends, clan lineages or notable events. Through the summer of 2017, students learned about the history of totem poles and created their own "pole" that, like a traditional totem pole, speaks to their story and what they believe in. Community Art Center Visual Art Teacher, Lionel Blaise, oversaw the artistic continuity of the project. The project was supported by a visiting artist who assisted the youth artists and was responsible for creating 4-5 additional totem poles using themes contributed by our youth. The project culminated in a celebration onsite featuring an ice cream truck, music and a short presentation by the youth artists.

Current Condition

The totems are currently showing their age after having been installed 7 years ago and have been bending, falling over, and weathering over the years. The totems often disconnect from the fence during high-wind events and must be resecured often.

Challenges and Obstacles to removal

There are no challenges or obstacles to removing this art installation.

Reasons for deaccessioning the art

The CRA is recommending the deaccession of this art in accordance with the following reasons as identified within the CRA Deaccession Policy (1/11/17):

- (1) The artwork's recent condition poses a safety hazard to the public.
- (2) The artwork has been damaged or has deteriorated to the point that it can no longer be represented to be the original artwork.
- (3) The restoration of the artwork's structural or aesthetic integrity is technically not feasible, or repair and conservation work will render the work false, or the expense of restoring it exceeds 50 percent of the original cost of the artwork.

Options for storage or disposition of artwork; appraised value

The artwork can be given back to the Community Art Center or can be disposed of. The Community Art Center has indicated that they do not want the art back as its is weathered and they do not have the storage space.

There is no value to the artwork.

Documentation of initial conversations with the artist

The Community Art Center, the organization that created the artwork with their students, has provided written approval to remove and dispose of the art. See Exhibit A for the attached email from Erin Muirhead McCarty, Executive Director of the Community Art Center, dated Monday, February 5, 2024.

Dear Cambridge Redevelopment Authority,

This letter will serve to document the agreement between the Community Art Center (CAC) and Cambridge Redevelopment Authority to design and complete a mural to be located at the Third Street Food Truck Lot (corner of Third Street & Binney Street) using resources and supervision provided by the Community Art Center. It will outline the Project Scope, Goals, Staffing, Communications, Milestones, Budget, Change Order process and Criteria for Acceptance for this project, known as My Totem Project We are pleased to provide this information to you and look forward to a mutually beneficial relationship between the Community Art Center and Cambridge Redevelopment Authority.

Introduction

Founded in 1932, the Community Art Center is a neighborhood institution committed to the following mission:

To cultivate an engaged community of youth whose powerful artistic voices transform their lives, their neighborhoods, and their worlds.

The Art Center has established an excellent track record of providing creative, challenging learning opportunities to low-income, high-needs youth. We do this in the context of a family-like environment with intensive social and emotional supports including academic help, mental health and transportation services and up to three full meals a day. Our programs promote our organizational values: We believe in the power of young people, we believe in the power of artistic expression, we believe in taking care of ourselves and each other and we believe in creating positive change in our neighborhood and beyond.

The Art Center achieves its mission through intensive, year-round activities for a core group of youth ages 5-19 and through youth-led community programming that engages local and national audiences in quality artistic experiences. Project Scope

The project will consist of a mural of approximately 60 x 8 feet (including 1' spaces between each 2'x8' panel and a 4' project description panel) to be located at the Third Street Food Truck Lot at the corner of Third and Binney Streets.

Project Overview

The My Totem Project supports Community Art Center students ages 9 to 12 in the exploration of identity, family and community through the creation of their own personal "totem poles." Each totem pole will be hand painted on 2' x 8' DiBond pieces. The final installation will consist of 18-20 panels hung vertically with 1' between each one, and will occupy approximately 60 feet of the chain link fence on the Third Street food truck lot. The panels will welcome visitors to the lot, and will have collective visual impact through the use of a common color scheme and design features. Traditional totem poles include symbols that express cultural beliefs or recount familiar legends, clan lineages or notable events. Community Art Center Visual Art Teacher, Lionel Blaise, will oversee the artistic continuity of the project. The project will culminate in a celebration onsite featuring an ice cream truck, music and a short presentation by our youth artists if the CRA and CAC can agree on a date/time that does not interfere with CRA operations and the Food Trucks currently on the site.
